



ANNUAL PROGRESS REPORT

October 2023–September 2024 | Zambia

SUMMARY

Thanks to your partnership, we made significant progress this year toward our goal to reach everyone, everywhere we work, with clean water. We finished the job in nine area programs, providing 764,242 people access to clean water. We have reached 317 schools with water on site since fiscal year 2021, achieving 91% of our five-year goal.

In all, 15 district-level universal coverage plans have been developed, including five in FY24. These plans were developed in coordination with district governments to allocate resources to WASH and meet our Finish the Job goal to ensure the sustainability of our investments.

Strengthening healthcare

Moreover, we exceeded our goal for piped water in healthcare facilities, reaching 41 clinics in FY24 for a total of 140 since FY21. In view of this success, we increased our target

to 149 by FY25. These upgrades have dramatically improved health outcomes for vulnerable people.

Promoting health and dignity

This year also marked tremendous progress in sanitation through partnerships with government agencies, local leaders, and communities. World Vision trained residents to improve their homes, resulting in the construction of 66.625 household toilets.

Three chiefdoms and four wards were certified Open Defecation Free, providing dignity and improved sanitation to over 356,000 people.

Protecting our environment

To promote sustainability, we trained 52 people in watershed management and environmentally friendly agricultural practices. These initiatives not only help protect natural resources but also provide income-generating opportunities.



Peggy, a midwife nurse at Kaluluzi Health Post, cleans medical instruments. This clinic received a new maternity ward with piped water, flush toilets, and a bathing room for new mothers. Since completion, the facility has recorded twice the number of births than before, now that mothers feel safe delivering at a facility with water access.


CHALLENGES AND ADAPTATIONS

The new government mandate for flush toilets in schools required World Vision to negotiate for more affordable alternatives, causing delays. As a result, all indicators for schools were below target. Nineteen toilets are under construction and expected to be completed in FY25.

Additionally, a drought led to water shortages and food insecurity. World Vision mitigated some impacts by providing 534 hand pumps, 80 rehabilitated water points, and 113 piped-water systems to rural communities.



PROGRESS TOWARD FINISHING THE JOB



Goal 1 million people

gain access to clean drinking water from FY21 through FY26.

Actual

764,242 people gained access to clean drinking water since October 2020, including 167,635 during FY24, achieving 76% of our target.

PLANS FOR THE NEXT SIX MONTHS

In FY25, three World Vision Zambia staff will present at the WaterNet Symposium in Lesotho on the impact of clean water on rural healthcare systems and the effectiveness of the Nurturing Care Groups community development model in improving child health outcomes through better sanitation and hygiene practices.

In addition, we will work with water utility companies to complete two large systems in Manyinga and Luswepo by the end of 2024. These systems will reach more than 5,000 people through 800 metered household connections.








FINISH THE JOB ZAMBIA
